Proposition No. 1  
(Millage Renewal)  
(Sewerage Department)

Summary: 10-year 1.14-mill tax renewal for acquiring, constructing, improving, maintaining and/or operating the City's wastewater collection, treatment and disposal system, including salaries and benefits of sewerage department personnel.

Shall the City of Kenner, State of Louisiana, under the provisions of Article VI, Sections 30 and 32 of the Constitution of the State of Louisiana of 1974, continue to levy and collect a special tax of one and fourteen hundredths (1.14) mills on all the property subject to taxation within said City, for a period of ten (10) years beginning with the year 2012 and ending with the year 2021, inclusive, for the purpose of acquiring, constructing, improving, maintaining and/or operating the City's wastewater collection, treatment and disposal system, including salaries and benefits of sewerage department personnel? (estimated annual revenues: \$513,000.00)

Proposition No. 2  
(Millage Renewal)  
(Garbage Collection and Disposal)

Summary: 10-year tax 1.61-mill tax renewal for acquiring, constructing, improving, maintaining and/or operating garbage collection and disposal facilities and/or services in and for the City, including salaries and benefits of garbage department personnel.

Shall the City of Kenner, State of Louisiana, under the provisions of Article VI, Sections 30 and 32 of the Constitution of the State of Louisiana of 1974, continue to levy and collect a special tax of one and sixty-one hundredths (1.61) mills, on all the property subject to taxation within said City, for a period of ten (10) years beginning with the year 2012 and ending with the year 2021, inclusive, for the purpose of acquiring, constructing, improving, maintaining and/or operating garbage collection and disposal facilities and/or services in and for the City, including salaries and benefits of garbage department personnel? (estimated annual revenues: \$725,000.00)

(Millage Renewal)  
(Fire Department)

Summary: 10-year 7.40-mill tax renewal for acquiring, constructing, improving, equipping, maintaining and/or operating fire department buildings and facilities, for acquiring, maintaining and operating fire department vehicles and equipment, and for paying salaries and benefits of fire department personnel.

Shall the City of Kenner, State of Louisiana, under the provisions of Article VI, Sections 30 and 32 of the Constitution of the State of Louisiana of 1974, continue to levy and collect a special tax of seven and forty hundredths (7.40) mills on all the property subject to taxation within said City, for a period of ten (10) years beginning with the year 2012 and ending with the year 2021, inclusive, for the purpose of constructing, improving, equipping, maintaining and/or operating fire department buildings and facilities, for acquiring, maintaining and operating fire department vehicles and equipment, and for paying salaries and benefits of fire department personnel?  
(estimated annual revenues: \$3,330,000.00)
