**Conditions Governing Publication/Display of Louisiana State Archives  
Photographs for Commercial Use**

(refer to *Policy on the Reproduction of Archival Images – LH 10*):

1. All requests for use of Louisiana State Archives collections materials, whether in publications, motion pictures, videos or performances will be considered on a case-by-case basis.
2. It is the responsibility of the patron to obtain any required copyright permissions from the copyright holder.
3. Some materials may require the Louisiana State Archives to assess a licensing fee for the commercial use of materials from its collections. The Louisiana State Archives reserves the right to judge whether a proposed use is commercial based on the nature of a project and its intended audience. The Louisiana State Archives also reserve the right to assess fees for the use of its material in non-commercial projects, in particular when use is deemed to be significant or extensive. Such fees are negotiated on a case-by-case basis and are intended to offset a small part of the Louisiana State Archives costs associated with processing, preserving and public service of its manuscript collections.
4. Use fees cover only the non-exclusive; one-time uses for the purpose or project described above, unless otherwise indicated, and are to be paid in advance. They are assessed in addition to any duplication costs. Subsequent requests for permission to quote or publish must be made in writing. A reuse fee may apply.
5. The citation and/or credit line of the *collection name, accession number and Louisiana Secretary of State: Archives Division* must be used unless otherwise agreed upon.
6. The Louisiana State Archives requires that 2 complete copies of any Publication (in any medium) that makes use of its materials be given to the Louisiana State Archives for its collections.
7. The Louisiana State Archives provides copies of its materials on a loan basis only and are subject to recall by the archives. Copies, including microfilm, are not to be further reproduced, sold, shared, or given to another person, company or institution for any purpose, without the written permission of the Louisiana State Archives.
8. **THE APPLICANT WILL DEFEND AND HOLD HARMLESS THE STATE OF LOUISIANA, SECRETARY OF STATE, THE DIVISION OF ARCHIVES, RECORDS MANAGEMENT & HISTORY, ITS OFFICERS, EMPLOYEES AND AGENTS AGAINST ALL CLAIMS, DEMANDS, COSTS, AND EXPENSES INCLUDING ATTORNEYS' FEES INCURRED BY COPYRIGHT INFRINGEMENTS OR ANY OTHER LEGAL OR REGULATORY CAUSE OF ACTION ARISING FROM USE OF SPECIAL COLLECTIONS MATERIALS.**
