The filing fee shall be \$75 for the reinstatement, plus \$30 for the most current annual report, plus \$30 for each annual report not filed between the last annual report and reinstatement (the prior annual report forms do not have to be submitted).
- 2. The corporation may be reinstated up to five (5) years after the effective date of the termination. If the five year window has expired, the corporation cannot be reinstated.
