NOTE: Each nominating petition should be circulated by one person who must execute the circulator's certificate. Also, each nominating petition should be signed by petitioners who reside in the same parish and Congressional District to be certified by the registrar of voters for such parish.

Instructions: Voter signatures MUST be obtained no earlier than 120 days before the qualifying period opens for candidates. A nominating petition MUST be submitted to the Registrar of Voters in the Parish where the signers reside no less than 30 days before the qualifying period ends for candidates in the primary election. The Registrar of Voters MUST endorse the date and time of receipt of the nominating petition in the space provided below:
