# Public Hearing — Substantive Changes to Proposed Rule — Recognition of Political Parties (LAC 31:I.905)

Under the authority of the Administrative Procedure Act (R.S. 49:950 et seq.) and under the authority of R.S. 18:441 and R.S. 36:742, the Department of State published a Notice of Intent to amend the rules regarding recognition of Political Parties in the September 20, 2018 edition of the *Louisiana Register*. If a political party wants to register as a recognized political party, they are required to procure a statewide list of all voters who are registered as being affiliated with the political party from the department. Consideration was given to an Advisory Opinion made by the Department of Justice concerning the fee for printing a list at an estimated cost of \$20. The original proposal for Section 905 is being resubmitted, as revised, for publication in the Potpourri Section of the *Louisiana* Register. The Department of State must make a substantive change to the LAC citation from LAC 31:II.105.C to LAC 31:II.105.C.1. Since these are the current fees, the original impact statement will still be applicable per our discussion with the Legislative Fiscal Office.

### Chapter 9. Recognition of Political Parties

### §905. Political Party Recognition Based on Registered Voters

Α. ..

B. The political party shall be required to purchase from the Department of State a statewide list of all voters who are registered as being affiliated with the political party in the state of Louisiana pursuant to the provisions of LAC 31:II.105.C.1 (Sale of Voter Registration Lists). The list of registered voters shall be dated by the department.
