## **QUALIFYING BEGINS WEDNESDAY FOR SPRING ELECTIONS**

Louisiana Secretary of State Tom Schedler reminds everyone that qualifying begins for the Spring Municipal Elections on Wednesday, February 12<sup>th</sup> and runs through Friday, February 14<sup>th</sup> from 8:00 a.m. until 4:30 p.m. daily. ALL CANDIDATES FOR LOCAL MUNICIPAL RACES WILL QUALIFY WITH THEIR LOCAL CLERK OF COURT. Once qualified, candidates will appear on the Secretary of State's website under "Elections & Voting", "Get Election Information", "Search for Candidates," or by clicking on the link below.
