# Public Hearing — Substantive Changes to Proposed Rule — Department of State Museums (LAC 25:VI.305, 307, 311)

Under the authority of the Administrative Procedure Act (R.S. 49:950 et seq.) and under the authority of R.S. 36:742, R.S. 36:744, and R.S. 49:222(A), the Department of State published a Notice of Intent to adopt rules and regulations for the Department of State's museums in the September 20, 2018 edition of the *Louisiana Register*. The Department of State conducted a public hearing on Tuesday, October 30, 2018 to receive comments and testimony on the proposed Rule. At the public hearing, the Department reported that it had received a written comment regarding the Louisiana State Cotton Museum using a per hour fee for rental rather than a per event fee which is currently being used. After receiving this comment, the codirectors of the Museums Program reviewed the Notice of Intent and it was noted that two other museums are currently using a per event fee rather than a per hour fee. Consideration was given to the comment received and as a result, the Department of State proposes to amend Sections 305, 307, and 311. The original proposal for Sections 305, 307, and 311 are being resubmitted, as revised, for publication in the Potpourri Section of the *Louisiana Register*. Since these are the current fees, the original impact statement will still be applicable per our communications with the Legislative Fiscal Office.

# Title 25 CULTURAL RESOURCES Part VI. Department of State's Museums

## Chapter 3. Museums Fees

#### §305. Louisiana State Cotton Museum Fees

- A. Daytime Events. Daytime events shall be held during regular business hours. The building shall remain open to the public during the scheduled event time although special arrangements may be made to restrict public access to event areas. All of the following daytime event fees include tables, chairs, janitorial service, and set-up and breakdown of the event:
- 1. for a four-hour event or less without food and beverage, the event fee will be \$50; and
- 2. for an eight-hour event or less with food and beverage, the event fee will be \$100.
- B. Evening Events. Private events shall be no more than four hours in duration and shall be scheduled after regular business hours. No event shall run beyond midnight. The event fee shall be \$300.
- C. All rentals require a 10 percent non-refundable deposit to reserve the date.

#### §307. Louisiana Delta Music Museum Fees

- A. Daytime Events. Daytime events shall be held during regular business hours. The building shall remain open to the public during the scheduled event time although special arrangements may be made to restrict public access to event areas. All of the following daytime event fees include tables, chairs, janitorial service, and set-up and breakdown of the event. The event fee shall be \$200.
- B. Evening and Weekend Events. Private events shall be held for no more than four hours in duration. The event fee shall be \$420. Evening events shall be scheduled after regular business hours. No event shall run beyond midnight.
  - C. A refundable damage deposit of \$100 is required for all rentals.

### §311. Louisiana Oil and Gas Museum Fees

A. Evening Events. Private events shall be held for no more than four hours in duration and shall be scheduled after regular business hours. The event fee shall be \$500. No event shall run beyond midnight.

B. A refundable damage deposit of \$250 is required for all rentals.
